<b>Notes:</b>	
1	This revised list (rev. 29), supersedes all previous lists. Since this list is periodically revised, clients are requested to check for the latest version (with DEWA Project Execution Department, Al Ruwayya) before engaging a contractor for their works.
2	Only the above approved contractors are permitted to undertake cable installation work in DEWA MV (up to 33 KV) or LV corridors.
3	All Cable installation works shall be undertaken, strictly as per "DEWA work instructions for private cable laying works" in coordination with (DPE) Distribution Project Execution Department.
4	In the event of theft, damage or failure due to poor workmanship including inappropriate handling / storage of materials, client and their engaged contractor will be held responsible, All DEWA free issue materials and affected assets as applicable. Additionally, the cost of testing and rectification works related to such incidents shall be recoverable from the client/ his appointed contractor. Such liability of the Client/ appointed contractor shall be till successful energization of the cables in case of 33 kV, 11 kV and private LV cables. For temporary LV cables clients shall be responsible for the whole service life of the installed cables.
5	Before energization of installed cables, it is mandatory to submit "FINAL CLEARANCE FORM" duly completed in line with "DEWA Work Instructions for Private Cable Laying Works" by client through their appointed contractor. Only such jobs will be taken up for commissioning works.
6	Clients can engage any one of the above approved contractors (approval type Approved or under observation) for their jobs, whose RTA ROW approval is still valid. (Clients are requested to confirm from the contractor that contractor's RTA ROW approval is still valid before forwarding the nomination letter to DEWA - as mentioned under clause 7).
7	<b>After finalizing their contractor, client shall send a letter addressed to Sr. Manager, Projects Execution Department, DEWA stating that they have engaged "....." contractor for their job and have authorized their selected contractor to collect the NOCs and materials (if applicable) from DEWA and execute the job on their behalf.</b>
8	On receipt of such nomination letter, DEWA shall release the required NOCs and materials (if applicable) to client's contractor.
9	The contractor shall execute the job strictly as per DEWA work Instructions for Private Cable Laying works.
10	Contractor being appointed and paid by the client, client shall follow-up with their contractor for the timely completion of the job, independent of DEWA. For any further clarification or guidance on this matter, the client shall contact (DPE) Distribution Project Execution Department.
11	Private contractor to make sure enough Jointer / manpower are available before taking up any major jobs, which will ensure the completion of the project within the stipulate time.
